- 1. Applicant is responsible for all personal and/or property damages.
- 2. Applicant must contact the public works department to arrange an inspection before pouring sidewalks that are in the R.O.W.
- 3. Applicant certifies that the work requested above and restoration thereof shall be performed in accordance with the City of Morgantown's Engineered Specifications for work within **RIGHT-OF-WAY**.
- 4. It is the applicant's responsibility to notify necessary utility companies and M.E.C.C.A (599-6382) when street closure is necessary.
- 5. Safe Vehicle/pedestrian passage must be maintained VIA: Cones, Barricades, Signage, Detours and/or Flagmen.
- 6. All necessary signs, cones, barricades – must meet MUTCD standards and are applicant's responsibility.
- 7. Arrangements must be made with the Parking Authority to work within or use metered parking spaces
- 8. All other necessary permits (building, grading, etc.) must be obtained prior to onset of work.
- 9. No construction materials (stone, sand, bricks, etc.) to be stored in street.

Traffic Maintenance Plan – University Avenue
2/16/2016

Work to begin 10/21/2015, target completion date 6/15/2016.

Work to be performed on University Avenue between North Street and Overhill Street, in front of Sunnyside Commons site.

Work to include staging trucks in ROW, staging material in ROW, installation of sidewalk, use of man lifts in city ROW, use of material lifts in City ROW.

95% of material for building A along University Avenue will be stocked with a Tower crane and out of the city ROW, but there may be some need for minimal lift traffic in city ROW. All material and man lift will be attempted from behind the City street curb and off of the city asphalt and concrete.

We do not anticipate any permanent lane closure for this project. If a permanent lane closure and light is needed in the future a new ROW permit will be submitted with a new traffic maintenance plan.

When required to temporarily close one lane of University Avenue for truck traffic and/or unloading we plan to use flaggers to safely route traffic around the blockage. 2 hour temporary lane closure intervals.

During this period the traffic maintenance plan includes the following:

Contact Mountain-line bus service to make them aware of extended lane or road closure.

Contact MECCA 911 to make them aware of extended lane or road closure.

Set up signage: "Road work ahead" (at North and Overhill) and "Flagger Ahead" (at North and Overhill).

Have one flagger at 100' before the construction entrance toward North Street and one flagger 50' before the blockage toward Overhill St. but not to go past Overhill St.
